3.	Community Partnership Board Update	
	Nicole Rickard (NR) highlighted the following points from the CP Board meeting:	



	<ul> <li>Cllr Caroline Topping, Leader of the Council was now Chair of the Community Partnership Board and Lisa Perkins from BT was continuing as Vice Chair.</li> <li>Seven of the eight Community Partnership Chairs are new, and so part of the meeting focussed on introducing the principles of the partnerships and work that had been done so far.</li> <li>Changes would be made to the Ease the Squeeze programme based on feedback and learning from the 2022/23 winter (presentation linked from the meeting papers).</li> </ul>
	<ul> <li>A workshop was held on skills to feedback on how funding from the UK Shared Prosperity Fund should be allocated.</li> </ul>
4.	Updates from Task and Finish Groups
	<ul> <li>Richard Cooper (RC) updated on the transport task and finish group:</li> <li>Priority had been to get Katch 2 up and running.</li> <li>The service had been launched in April, and the online booking app had been launched in July to complement phone bookings.</li> <li>The priority was now to ensure that people were aware of the service and could access it.</li> <li>Service was being promoted on social media and community venues (doctors surgeries etc.), and would also be promoted in schools.</li> <li>Numbers were currently low, and RC asked attendees to promote it in their communities.</li> </ul>
	<ul> <li>The Partnership raised the following points:</li> <li>Julia Ewart (JE) asked why Rendlesham had not been included in the route. Alexander Nicoll (AN) commented that existing community transport to the area were not well used. It was essential that people used the service as it would be lost. The time might be right to revisit this as personnel had changed.</li> <li>Klaus Fortmann (KF) stated that concerns had been raised about the costs, and the inability to use concessions. RC commented that the cost was comparable to a bus, but work needed to be done on how it could be made accessible to people with a concession through the county voucher scheme.</li> <li>Marketing of the service also needed to be considered, as people did not think the service was for them.</li> <li>SCC have a pilot scheme for e-bikes in rural areas, Sam Kenward was looking at how this could be applied to this area.</li> <li>SK commented that it was important that transport in the area was considered as a whole, rather than each service being looked at as a single point.</li> </ul>



	<ul> <li>Sam Kenward (SK) updated on the mental health task and finish group</li> <li>The current focus was on young people and mental health</li> <li>This had stalled due to a change in officers, but SK would be getting this going again</li> <li>Intergenerational skills</li> <li>There had been a good start on this in looking into options in this area in terms of choirs and men's sheds, and the task group now needed to spend time looking at how these could be started.</li> </ul>
5.	Election of a new member
	On the unanimous agreement of the Community Partnership, Anne Westover was elected as a new member.
	SK stated that JE has highlighted that the name was currently the Framlingham, Wickham Market Community Partnership, and this missed one of the wards out in the area. It was proposed that the name be changed to the Framlingham, Wickham Market, Kelsale, Yoxford and villages Community Partnership.
	On the unanimous agreement of the Community Partnership, the name was changed to the Framlingham, Wickham Market, Kelsale, Yoxford and villages Community Partnership.

# Communities Officer update 22<sup>nd</sup> September 2023

#### Task and Finish Groups

- Transport
  - One meeting has taken place with Cllr Richard Cooper, Cllr Julia Ewart and Jane Healey on board
  - It was agreed that it was important for some mapping to take place to establish a baseline about what is currently available and where potential gaps might be
  - This mapping is currently being looked at by the group and at the Get together events to identify if there are any particular gaps or any opportunities at the local level
  - This will be pinged around in due course for the wider CP more generally to sense check
  - Once we have a more comprehensive account which we're confident is accurate, we will then look at areas where there is no or low provision and look to do some targeted engagement with local stakeholders to see why this might be the case and what could be done
  - Options could be promoting services more that already exist locally like Connecting Communities (to raise awareness and usage), looking into extending something that runs nearby or potentially scoping out something new but being mindful of what is achievable
  - There have also been conversations around how to use local opportunities to promote Katch using local networks.
- Mental health
  - No meeting as yet but in conversations meeting people as I go round the patch, I've been able to collate some key themes and potential ideas for this strand and these ideas are in the potential projects item
  - Have had some good engagement from Wickham Market Primary School around working with young people to see what they believe would be good for this
- Intergenerational skills exchange
  - No meeting as yet but in conversations meeting people as I go round the patch, I've been able to collate some key themes and potential ideas for this strand and these ideas are in the potential projects item

#### Stakeholder engagement

- In my initial trips around the patch and conversations, I have been able to develop a sense of some of the key local issues and needs
- Some preliminary soundings and observations are:
  - Traffic and speed are very big issue in rural area this is obviously outside the remit of the CP but it is interesting to see what makes different parishes tick and how work on these difficult issues can mean less time to focus on other things
  - Parishes are also mindful about opportunities for their local residents to get together at coffee mornings or to travel to their nearest hub town (but can't always do this as there is unreliable transport)
    - It has been useful to see what are those key factors which might potentially link in with the CP

• Good initial conversations with FAYAP, CYDS and Wickham Market Primary School

## Ward get togethers

- This project is a variation of the Mini CP forum that was agreed previously
- The first 2 events have taken place (Huntingfield for Kelsale and Yoxford and Wickham Market for WM ward) the next one is Framingham on 10<sup>th</sup> October
- A good 2 events have been held to inform more about the community partnership and funding opportunities
- From the Kelsale and Yoxford one, there were 12 attendees and two potential new recruits for the CP one parish council and one community group
- From the Wickham Market one, there were 24 attendees and good linkages created over neighbourhood plan learning and working together around cost of living
- There have also been conversations about potential projects that could happen including a sharing library of resources and a network of bicycle repair stations to make it easier for people to get about using sustainable travel.

#### What has gone well?

- Katch continues via ESC
- Getting funds relatively 'easy'





#### What could improve?

- Access to the CP everybody to know about it as a good place to be FB/Web
- More funding
- More involvement from County councillors 1 here tonight; how often do the other 2 come?
- 6pm start time is no good 6.30 is better; but still difficult for working cllrs and clerks. Meetings would be much more attractive if 7-8.30!
- More communication and links with community and charities
- Use funds to extend communications to wider audience
- Marketing/info/dispense i.e Katch
- Youth climate event showcasing things happening in local areas
- Need more pre-meeting prep work so everyone knows who is attending before the meeting seemed a bit chaotic and didn't really learn/progress anything
- Katch, dynamic marketing, filter down to more people to be mentioned on more parish comms
- Organise events for YP to upskill
- Emails need a few bullet points enticing them in to read all the attachments re: meetings
- Environment/climate crisis/sustainability really needs to be one of our priorities cycle lanes etc
