EXECUTIVE SUMMARY

- 1. This report provides a snapshot of the current number and type of licences issued by East Suffolk Council. The Licensing Team propose to report against the various types of licence issued quarterly to track the rise and fall in demand for various licences for the purpose of trend analysis. The collating, reporting and analysis of this data should assist the Licensing Team, and the wider Council, in making data driven decisions.
- 2. The report also summarises the applications received and the work of the Licensing Sub-Committee in 2019.

1 INTRODUCTION

- 1.1 The Licensing Team intends to start reporting quarterly on the number and type of licences issued by East Suffolk Council, the outcome of the applications received and the decisions of the Licensing Sub-Committee.
- 1.2 It is hoped that the collating, reporting and analysis of this licensing information will help to identify trends which could shape the work of the Licensing Team and the wider Council and assist in the taking of data driven decisions.
- 1.3 Reporting on the decisions taken by individual meetings of the Licensing Sub-Committee will provide all Councillors with an overview of the work of the Sub-Committee, which undertakes the bulk of the work in licensing.

2.3 Current applications

Appeals to Magistrates' Court:

The decision of the Licensing Sub-Committee on the Village Rise review application has been appealed to Ipswich Magistrate's Court. The first hearing of the appeal, where case management directions will be agreed, has been listed for 3 February 2020.

28 day consultation period has passed and application is still to be determined:

There are currently no applications waiting to go to a hearing.

In consultation:

New Premises Licence - Smashing Wines, Unit B14, Base Business park, Rendlesham, Woodbridge, IP12 2TZ. Consultation period ended 6 January 2020.

3. NUMBER OF PREMISES LICENCES WITHIN EAST SUFFOLK

- 3.1 On 1 April 2019 there were 991 Premises Licences and 823 of these included alcohol on the licence.
- 3.2 Two Premises Licences were issued after 1 April for one-off events that happened in 2019 and are therefore no longer licenced.
- 3.3 19 Premises Licences were surrendered or lapsed between 1 April 2019 and the 31 December 2019.
- 3.4 On 1 January 2020 there were 1002 Premises Licences and 851 of these included alcohol on the licence.
- 3.5 There were 68 Club Premises licences with Alcohol on 1 April 2019 and on 1 January 2020 there were 69 as a new Club Premises Licence was granted on 4 April.
- 3.6 In summary, on 1 April 2019 there were 1059 and on 1 January 2020 there were 1071 Premises & Club Premises Licenses.

4. GAMBLING PREMISES LICENCES FOR EAST SUFFOLK

- 4.1 No new applications have been received since 1 April 2019 for any type of Gambling Premises licence.
- 4.2 On 1 April 2019 there were 42 Gambling Premises Licences in total, as of 1 January 2020 there were 40.
- 4.3 There were nine Bingo Premises Licences
- 4.4 There were 11 Adult Gaming Centre Premises Licences, on 1 April 2019 there were 12 however, one licence was cancelled in September.
- 4.5 There was one Family Entertainment Centre Premises Licence.
- 4.6 There was one Betting Premises Licence (in respect of a track)
- 4.7 There were 18 Betting Premises licences (in respect of a premises other than a track), on 1 April 2019 there were 19, however, one cancelled in December.

5. TAXI LICENCES

- 5.1 On 1 January 2020, East Suffolk Council licensed:
- 5.1.1 136 hackney carriage vehicles and 237 hackney carriage/private drivers
- 5.1.2 349 private hire vehicles and 352 private hire drivers
- 5.1.5 72 private hire operators
- 5.2 In 2019, there were eight meetings of the Licensing Sub-Committee on taxi licences in the North of the district and one Sub-Committee meeting on taxi licences in the South of the district.

6 HOW DOES THIS RELATE TO THE EAST SUFFOLK BUSINESS PLAN?

6.1 Licensing plays an important role in the building of a strong, sustainable, and dynamic local economy and in ensuring East Suffolk remains a safe place for our communities.

7 REASON FOR RECOMMENDATION

7.1 To consider a snapshot of the currently issued licences in East Suffolk as a starting point for analysing trends in demand for different types of licence over time and to review the work of the Licensing Sub-Committee in 2019.
