Hello,

In an excel document attached, I have put together everything requested on your website, along with the details to view each film.

The following information is also included:

- name of the filmmaker
- a brief synopsis of the film
- running time of the film
- any recommendation as may have been made by the filmmaker upon age limit for the intended audience for exhibition of the film
- language spoken in the film and whether there are subtitles in English

On the basis of how we would enforce any age restrictions:

- Our booking system will clearly state the age rating of the film/chosen screening and when prompted to complete the booking of tickets, users will see a notice advising them that the content in the showing may be unsuitable on the basis of each individual rating and ID may be requested upon entry to the screening to ensure the appropriate age audience members are watching the content.
- Our Age rating policy will be made clear on our website and venues, and for any PG rated screenings, any young children who may look or who may be deemed by our stewards to be under the age of 8 and are unaccompanied by a parent/or guardian will be refused entry.
- For 12A rated films, we will request ID for those that look under the age of 12 in order to watch the screening and for any films that may be rated 15 and above we will adopt the national challenge 25 scheme by requesting ID of anyone that looks under the age of 18.

The festival this year takes place across 20-27 October 2023.
