# Forthcoming projects and applications

#### Nautilus / Eurolink

National Grid Ventures, reclassified as a Multi-Purpose Interconnector, connection offer to Friston National Grid substation (not yet consented). Non statutory consultation late summer 2021, formal consultation anticipated end 2021/22.

National Grid Ventures provided an update on the projects during a briefing meeting to Councillors on 22 February 2021 and held a webinar with town and parish councils on 1 March 2021.

#### • SCD1

National Grid, interconnector between Suffolk and Kent, no further detail. Formal consultation 2021/22? Early stages but expected to be moved forward this year, earliest in service date is 2029.

#### Five Estuaries

Formerly known as Galloper extension, had connection offer, previously identified to Friston substation (not yet consented) but this could change, anticipated connection date 2030, very early stages. Little known.

#### North Falls

Formerly known as Greater Gabbard extension, has a connection offer but the location is not identified, anticipated connection date 2030, very early stages, little known at this stage.
