2	Notes of last meeting 20 July 2018 Approved apart from small amendment to section 4 in regards to Segway.	14:05
3	EDF Energy Update (Philip Ridley / Bryn Griffiths) Brief discussion on EADT article re: SEGWay. <ul style="list-style-type: none">• Case for Segway Stronger than ever = due to SZC & wind farms contractors.• If don't get funding from DfT will loss out of EDF Energy part funding.• If SEGway not fully funded, EDF Energy will proceed with a two village bypass.• If SEGway constructed it will help boost support for SZC, ease pressure on A2, reduce impact on communities - Protest against Segway & 2 Villages would be the same , but if do not get SEGway will have equal amounts of protest so SEGway would have the least unhappy / protest in accumulation Time critical to get this case across to Government. Rail –further work required with regard to rail mode of transport. Looking at the history of the rails routes, already old routes built just need: rails ballast, & signals. Officers are now restarting Workshops with EDF Energy for example Design workshop proposed for August/September.	14:10

4	<p>Coastal Processes Update (Bill Parker) –</p> <p>Brief introduction into Coastal Partnership East team & their remit. – Cover 175km of coast SCDC, WDC, Great Yarmouth & North Norfolk (not King’s Lynn - different coastal Region) also talk to the Boards Authority.</p> <p>Marine Technical Forum has not meet in over 2 years, so have not had any additional information from EDFE since than.</p> <p>Key coastal areas of concern: Coralline Crag. Foot Print of SZC – on the coastline. Mitigation – need to a robust legal frame work example Great Yarmouth harbour.</p> <p>EDFE have been reluctant to share data, Lord Deben had agreed a meeting between Scar & EDFE & any information was brief & could not be taken out of meeting.</p> <p>Design of SZC. Historical erosion rates are episodic events on the East coast example Dunwich, Aldeburgh’s – need to know more of the long term sandbar movements.</p> <p>Need to make sure future generation do not have to pick up the costs. Discussed that EDFE are only confident up to 20 years on what impact there will be on the coast. Not seen all the data nor all the scenarios. Also EDFE has the coastal process data as confidential, but what in respect of coastal process is confidential – shouldn’t be.</p> <p>EDFE only confident in coastal process for 20 years this is only for an 8th of the SZC lifetime , Social –economic impact , if Minsmere lost East Suffolk would need a replacement that has the same economic benefit in the area.</p>	14:37
